Sakhalin Energy Investment Company Ltd. (Sakhalin Energy) is the operator of Sakhalin-2 project in accordance with Production Sharing Agreement. The company was established in 1994 to develop oil and gas fields off the north-eastern coast of Sakhalin. Sakhalin Energy operates three offshore drilling platforms, a system of pipelines, processing and storage facilities, as well as twotrain LNG plant with the design capacity of 9.6 million tons per year that produces LNG since 2009. Sakhalin Energy's shareholders are Gazprom, Shell, Mitsui and Mitsubishi.
